

Coordination tools – EUSAIR Governance revision

- Sovernance Architecture Paper (GAP) was revised after 2014.
- > GAP defines EUSAIR governance bodies, their functions, roles and interrelations.
- > Developed during January October 2024 by Croatian and Greek Presidencies.
- At 23rd GB document was finalised and is considered valid, formally it will be approved with EUSAIR Action Plan endorsement.

<u>Next steps</u> (end of 2024, begining of 2025):

- Development of EGP Guidelines defining relations, roles, services, contacts of EGP and governance bodies previously Modus Operandi
- Development of **RoPs drafts** (GB, TSGs) as support to Presidency more efficient procedures
- Development of Pillar Roadmap for Actions template as support to Pillars more detailed plan on implementation of Actions

Coordination tools – Annual workplan, EUSAIR Planner

- Workplan 2024 monthly updates on plans for events and activities concerning EUSAIR for 2024, in development for 2025
- EUSAIR Planner confirmed events, consolidations in progress, holidays in 10 countries inserted in calendar
- Excel files updated on intranet (consolidated with FP PPs, StEP and SP4EUSAIR)

Coordination – Facility Point, EGP, cross-MRS

- Monthly Facility Point Partnership Working meetings
- > FP in Person Steering Group Meeting, Corfu, 2-3 October 2024
- Regular online coordination meetings of the EGP Joint Steering Committee (LPs) of 3 projects and 2 in person meetings – shared organisation, regular updates of Annual Workplan
- Cross macro-regional exchanges cooperation in Interact working groups on communication, M&E, capacity building, embedding; organisation of 4 MRS SU meeting

Actions supporting horizontal/crosscutting topics - Innovation

- Revitalisation of EUSAIR S3 Network together with StEP Izola, 17 September 2024
- EUSAIR S3 authorities meeting 10 national and regional authorities, out of 19 invited
- Study in ½ of 2025:
 - on S4 complementarities, potentials for interregional cooperation
 - identification of possible cooperation topics/projects linked to EUSAIR Actions
 - Recommendations for future cooperation model
- Panel on better cooperation and synergies between MRSs and S3, Izola 17 September 2024


