

Support to TSGs and PCs

- Organisation and support to Spring 2025 meetings of 6 Thematic Steering Groups:

Support to EUSAIR Youth Council – 2nd Call



- Selective 2nd Call (for countries for which current YC members end their mandate)
- 2nd Call start in April 2025
- 2025 YC in place in October 2025

Support to EUSAIR Youth Council – Revision of selection methodology

- In discussion within Youth Consultation Task Force, at NC Technical meeting, at Governing Board
- Main point EYC to represent position of Youth or EYC to bring to EUSAIR thematic expertise
- Inclusion of thematic competence criterion to be evaluated by Pillar Coordinators

Support to EUSAIR Youth Council – development of RoP

- > 2 Main parts:
 - Establishes main principles, vision, and values of the EUSAIR Youth Council.
 - Regulates the procedures, membership, and activity of the organisation.
- What the EYC envisioned in RoP
 - Advisory role of EYC (representiong youth perspective on issues & provide recommendations)
 - Operational Aspects of EYC (meetings, voting procedure & communication)

Support to EUSAIR Youth Council – development of RoP

- Interaction with TSGs
 - **EYC** Pillar Groups for each TSG/Pillar (2-4 EYC members) following the work of each Pillar
 - Meeting of EYC Pillar Group before TSG meetings to present EYC positions on agenda points
 - EYC Pillar Group representative spokesperson bringing EYC inputs to the TSG meeting
 - Each TSG/Pc to decide whether all EYC members (or just Pillar representatives or just members of EYC Pillar Group can participate to the TSG meeting and in what role (speakers/observers) – important to agree for the Spring TSG meetings
 - Topics for EYC inputs: EYC Pillar Group can decide on which topics inpuits shall be brought to TSG or PCs/TSGs can request an EYC input on a certain topic

Support to EUSAIR Youth Council – development of RoP

- Travel and accommodation costs of EYC representatives to EUSAIR meetings (GB, TSG) under discussion
- Travel and accomodation costs to in person thematic events no systematic approach, to be covered by organisers of the event on their initiative
- EYC Inauguration event at the 10th EUSAIR Forum


Capacity Building

- Newcomers kit 1st Draft developed, under consolidation process






4. Monitoring and Evaluation of EUSAIR

- Progress Report 2024 December 2025
- Preparation of a specific system of monitoring and evaluation indicators of the Pillars of EUSAIR – January 2026
