














#### $\Delta$ % Arrivals & Receipts during SARS



#### $\Delta$ % Arrivals, Global Economic Crisis






#### Of all crises, global arrivals returned to growth the fastest after SARS (5 months)









# Capacity(ASK) & Revenue (RPK)




# Depth of impact




# Flights traffic variation

















# Total T&T GDP loss projection Europe 2020, US\$



#### **Tourism** Manifesto **URGES EU GOVERNMENTS TO:**



Establish common criteria & thresholds for epidemiological risk



Implement common measures upon departure to & return from risk areas, incl:

- Replacing quarantine with testing and tracing
- Avoiding blanket restrictions to free movement with targeted measures instead
- Avoiding travel restrictions on passengers in transit




Publish clear, comprehensive & timely information about any travel restrictions where necessary

We propose that the Schengen members that are not in the EU would also join the green-zone travelling network.






